## BILTON LEDON Technology PRODUCTS ROHS- and REACH-compliant

---

Dear customers

since 15 January 2019 is the revised Regulation (EC) No 1907/2006 of the European Parliament and of the Council on the Registration, Evaluation, Authorization and Restriction of Chemicals (REACH) has been in force. REACH stands for Registration, Evaluation, Authorisation and Restriction of Chemicals. The Regulation distinguishes between chemical ("substances on their own and in preparations") and non-chemical products ("substances in articles").

BILTON LEDON Technology GmbH (BLT.), as a manufacturer of non-chemical products, is considered a "producer of products" (controls, LED modules and luminaires) in accordance with this regulation. Since no chemical substances are released when our products are used under normal and reasonably foreseeable conditions, the provisions of the so-called "candidate list" (substances of very high concern) apply to BILTON LEDON Technology GmbH (BLT.). Professional customers must be given by the producer or importer of those products which contain a substance of the "Candidate list" of more than 0.1% by mass per product sufficient information on the safe use of the products. At least the name of the substance used must be available. However, notification to the European Chemicals Agency (ECHA) must be made by June 1, at the latest for the production or import of substances weighing one tonne or more per year.

The Publication of the candidate list (as of 15.01.2019) in accordance with Article 59 (1,10) REACH (EC Regulation No. 1907/2006) can be found at the Internet address of the European Chemicals Agency (ECHA) [echo.europa.eu](http://echo.europa.eu). Manufacturers and importers of articles shall provide their customers with sufficient information about the substances used in the product, where the products delivered contain substances of the "Candidate list" in the product above 0.1 % by mass.

Chemicals are also used in our manufacturing processes. In the event of an obligation to register, these are registered by our upstream supplier - and not by BILTON LEDON Technology GmbH (BLT.). In this case we are the processing producer. We are in constant contact with our suppliers in order to obtain all necessary information as well as for the further processing with the chemical components necessary for us.

Our products meet all the requirements of Directive 2011/65/EU and the extension 2015/863 / EU on the restriction of the use of certain hazardous substances in electrical and electronic equipment (RoHS). BLT. products also contain the following substances: polybrominated biphenyl (PBB) and polybrominated diphenyl ethers (PBDE) lead, hexavalent chromium and cadmium. The legal maximum values are not exceeded in any way.
